COOKIE POLICY**

This Cookie Policy (hereinafter referred to as the "**Policy**") has been prepared by Remed Uluslararası Destek ve Danışmanlık Hiz. Tic. A.Ş. (hereinafter referred to as **Remed Ethics Line**) under the European Data Protection Regulation.

You can visit our website without providing any personal information and meet your needs by getting information about our products and services. Cookies are used to collect information about site usage during visits. Our purpose here is to provide convenience to the user who visits our website and to understand how we can improve the functioning.

**WHAT IS A COOKIE?**

A cookie is a small text file that is saved on your computer or mobile device through your browser when you visit a site. Cookies allow a site to operate more efficiently as well as provide personalized pages to better suit your personal needs and provide a faster visiting experience. Cookies only contain information about your visit history on the internet and do not collect any information about files stored on your computer, tablet or mobile device.

**HOW ARE COOKIES COLLECTED?**

Data is collected through your devices through which you access browsers. This collected information is device specific. It can be deleted by the user at any time and access to the information can be closed.

**TYPES OF COOKIES AND PURPOSES OF USE**

Cookies can come in different types according to different classification types.

There are two types of cookies according to their validity period: Persistent Cookies and Temporary Cookies. Temporary cookies are created when you visit the website and are only valid until you close your browser. Persistent cookies are created when you visit the website and remain until you delete them or they expire. Persistent cookies are used to perform operations such as providing a personalized experience compatible with your settings.

The types of cookies used on our website and their intended use are described below.

<p><b>Obligatory Cookies</b></p>	<p>It is mandatory for our website to function correctly. For example, mandatory cookies are used for purposes such as preventing logged-in members from having to re-enter passwords when visiting different pages on our website, showing visitors the images and files of the company belonging to the account they are logged in to. These cookies are used for security and verification purposes and are not used for any marketing purposes. These cookies are temporary and are deleted after the browser is closed.</p>
<p><b>Cookies Required for Performance and Analysis</b></p>	<p>Cookies that help to improve our website. Such cookies collect information about visitors' use of the site, are used to check that the site is working properly, detect errors received and improve the performance of the website.</p>

The processing of personal data by means of such cookies is based on the processing conditions of the European Data Protection Regulation, where the processing is necessary for the performance of a contract to which the data subject is a party or for taking steps at the request of the data subject prior to entering into a contract and where the processing is necessary for the purposes of those interests.

As Remed Ethics Line, we may share your personal data within the scope of the clarification text with third parties, our affiliates, business partners and group companies from which our company benefits from the services of our company, limited to the realization of the above-mentioned purposes and in accordance with the legislation.

**Cookie Consents:** By using our website on your electronic device, you can consent to the use of cookies in accordance with the Policy, or if you do not want to accept our cookie applications, you can refuse from the cookie

preferences section. If you reject cookies, our website or mobile applications may not function properly or may cause disruptions during the provision of the services you have requested.

Information about the use of cookies will be provided in a pop-up window on the first visit to our website.

**Cookie Management:** You can manage and clear cookie data stored until you disable cookies. The location of these settings varies depending on the browser you are using. You can locate the relevant settings by using the “Help” function in your browser. In order to control the use of cookies, you have the opportunity to customize your preferences regarding cookies by changing the settings of your browser from the browsers in the table below.
